These high deductible plans pay the same benefits as Plans F and J after one has paid a calendar year \$1,790 deductible. Benefits from high deductible plans F and J will not begin until out-of-pocket expenses exceed \$1,790. Out-of-pocket expenses for this deductible are expenses that would ordinarily be paid by the policy. These expenses include the Medicare deductibles for Part A and Part B, but do not include the plan's separate foreign travel emergency deductible. Regence BlueShield does not offer the high deductible Plan F or J.

If you are replacing another health care contract, do NOT cancel it until you have actually received your new contract and are sure you want to keep it.
